### **CTE Spring Data Collection in AIM—due date: April 30, 2010**

The spring Career and Technical Education (CTE) data collection began March 1 and ends on April 30, 2010. High Schools need to identify all students in grade 12 who were enrolled at any point during the 2009-2010 school year and have met the definition of a CTE Concentrator. CTE Concentrators are high school seniors who have earned three (3) or more courses or credits in any CTE area of concentration or a 'blend' of more than one area if a majority cannot be determined. Courses students are currently enrolled in may count toward credits earned. Schools who receive funding from the Carl D. Perkins federal grant program are required to complete this spring data collection. Students meeting the definition of a CTE Concentrator must have the Concentrator box checked and an Area of Concentration entered into the AIM system. The Career Path field is not required for the 2009-2010 school year. Instructions for completing the CTE data collection are located on the OPI AIM Web page. ### **CTE State Funding Application—due date: May 31, 2010**

The annual CTE State Funding application form required for the 2010-2011 State Career and Technical Education funding for the upcoming school year has been mailed to each Montana public school district superintendent. The application must be completed and returned on or before June 1, 2010. (The form says May 31, but that is a holiday. We will extend the deadline to the next working day.) An electronic fill-in version is also posted on the CTE web page under 'Forms and Timelines' and located on the OPI web site. The state application is separate from the Carl D. Perkins application which is part of the OPI electronic E-Grants system. ### MONTANA FCCLA HOSTS STATE LEADERSHIP CONFERENCE IN BILLINGS, MONTANA

More than 950 Montana Family, Career and Community Leaders of America (FCCLA) members, advisers, alumni, and guests from across the state gathered in Billings, Montana, March 18 – 20, for the 63<sup>rd</sup> Annual State Leadership Conference.

While in Billings, members had the opportunity to “Strike the Right Note with FCCLA!” and build leadership skills, view area businesses to learn about careers, and compete in National STAR (Students Taking Action in Recognition) Events and State Proficiency Events. The winners of each STAR Event are eligible to compete at the FCCLA National Leadership Conference July 4-8 in Chicago, IL. Medals awarded included 186 gold medals, 141 silver medals, 148 bronze medals, and 42 certificates of participation.

At the opening general session, 2009-2010 Montana FCCLA State Officers used a skit titled “FCCLA Idol” to present information on many of the FCCLA National Programs. The keynote speaker, Grant Baldwin, used humor and creativity to cause members to think on relevant issues such as leadership, making a difference, responsibility and personal finance. On Friday, members attended awareness sessions on topics including diversity education, smart teen driving, storytelling through songwriting, skin cancer prevention, and healthy relationships.

Montana FCCLA was proud to present a check to Children’s Miracle Network representatives for over \$13,000 during the conference. As the 2009-2010 State and National Outreach Project, members worked hard to raise money as well as making and donating items such as quilts, hats and pillows. All money raised for this project will remain in Montana at the Shodair Children’s Hospital in Helena.

The 2010-2010 State Executive Council was installed on Friday evening, and it includes thirteen high school students from across the state. Montana FCCLA State Adviser, Megan Anderson from the Office of Public Instruction, will work with this new group of state officers to plan the 2011 State Leadership Conference.

Health science students just returned from the 2010 HOSA State Leadership Conference that was held at the Billings College of Technology-Health Science Building. (HOSA is an acronym for Health Occupations Students of America) This year HOSA membership has grown to 161 participants, with new chapters at Augusta High School, CM Russell in Great Falls, and Capital High School in Helena. Professors and college students from MSU-Bozeman, MSU-Billings, Rocky Mountain College and Billings COT judged events. Students competed in events such as: biotechnology, sports medicine, forensic medicine, nursing assisting, veterinary assisting, medical math, medical terminology, and creative problem solving.

HOSA offered health-related educational symposiums for students right after the competitive events. This year HOSA members had a chance to visit with:

- The veterinarian from Zoo Montana;
- They toured United Blood Services and learned how and why blood is separated and what each component is used for;
- They participated in an Athletic Training session at MSU-B;
- Toured both the Billings Clinic Cancer Center and
- the Birthing Center.

Friday night HOSA members celebrated their accomplishments with a party at the indoor waterslide park in Billings.

The HOSA SLC theme was "Globalism of Health Care". Health professionals from Billings who have practiced medicine in third world countries were invited to join us for breakfast and visit with students. Our keynote speaker, Dr. Genevieve Reid (an OB-Gyn from Livingston, MT), talked about her work in Pakistan, Afghanistan and South American countries where she practiced maternal and child care.
