



CAREER AND TECHNICAL EDUCATION UPDATE October 28, 2010

New CTE Professionals Workshop

The Career & Technical Education division's specialists and staff hosted a New Career and Technical Education Professionals Workshop at the UM-Helena College of Technology Wednesday, October 20, 2010.

Over 40 middle school and secondary career and technical education professionals from around the state attended the free one-day workshop to gain information on the many hot topics of career and technical education at the state and national levels. Those in attendance were classroom teachers from the various career and technical education areas including agriculture education, business education, family and consumer sciences education, and industrial technology education.

Attendees participated in two joint morning sessions addressing Carl Perkins and state funding and the Career Clusters, Big Sky Pathways, and various STATEwide ARTiculation (START) agreements. The morning joint sessions were followed by an area-specific breakout session covering professional organizations, professional development opportunities at the state, regional, and national levels, and resources for curriculum development and classroom management.

The afternoon focused on career and technical student organizations (CTSOs) and providing new advisors with tips, tricks, and resources for developing a local chapter and implementing a successful program of activities.

The workshop was a great success with quality information being passed on to the classroom teachers and with quality discussions during the sessions. The workshop also provide an excellent venue for new career and technical education professionals to network and build professional relationships they can draw upon as they continue their careers within the career and technical education professional.

Perkins Fall Data Collection in AIM continues

The fall Career and Technical Education (CTE) data collection began October 1 and ends December 31, 2010. The fall CTE data collection is a follow-up to the Spring CTE Collection. Students identified as CTE Concentrators who graduated in the 09-10 year must be contacted between October 1 and December 31, 2010 and have their current post-graduation status identified in the Achievement In Montana (AIM) system. Schools who receive funding from the Carl D. Perkins federal grant program are required to complete this fall follow-up collection. Instructions for completing the CTE fall data collection are located on the OPI AIM Web page.
